I'll often "run" my website rental business while sitting in a lounge chair on a beach in the Philippines watching the sun set out over the South China Sea :-)

I already split my time between the U.S. and the Philippines. Here's where I attended a family reunion on my favorite beach which does actually overlook the South China Sea :-)





You see, of all the businesses that you can operate on the internet, I believe that the MOST profitable ones are generating customers-traffic-leads-clients for other business owners.

Yes, I did include Amazon since Jeff Bezos of Amazon IS in the business of collecting eyeballs and then redirecting those eyeballs to products and services ... and that has led to him being projected to...

in the not too distant future, become the world's first TRILLIONAIRE.

Wrap your mind around that...

A million is a thousand thousands, and a billion is a thousand millions, and a trillion is a thousand billions!

So we're talking about someone making thousands of billions from basically being able to capture and redirect traffic.

Have a cup of coffee, or hot chocolate, and let that sink in while you sip it. In days gone by, I would have added a little Amaretto or rum to my coffee or chocolate to help "loosen my imagination." I no longer do that, nor do I need anything other than my own power of observation to perceive that CONTROLLING TRAFFIC, is one really proven POWERFUL pathway to incredible wealth.

Actually it's not just controlling traffic, but also controlling people's THOUGHTS.

... but we won't get into what gives politics, religions, entertainment, the media... and yes even Facebook... its power.

YOU feed off of getting likes, shares, thumbs up, and smiley faces :-)

But let's not go too deep down that rabbit hole...

Let's get back to the potential for you to control some of that traffic.

As [the video on YouTube](#) will share... I think... I've been buying and selling domain names for a dozen years, and once I discovered that it is generally MUCH more profitable to rent them than to just sell them, I put a lot of focus on building and renting as many web properties as practical.

I have quite literally spent thousands of hours studying "domaining" buying and sell, ranking and renting, etc. ...basically treating domain names and websites as an investment.

I actually think of it more as a CURRENCY than an investment, but let's not split hairs right now.

Like many, I have spent a LOT of time looking for "the secrets," and as any honest multimillionaire that you will REALLY LISTEN to will tell you... there are NONE!

Yes, you can leverage technology, outsourcing, capital, or the experience of others... and that is what I have done ... but that's no secret.

When you can step in between some of these elements of wealth creation, and engage in ARBITRAGE, and when you fully understand that POWER...

Well, let me WARN you... it can be very intoxicating!

"It" DOES require some work... which you need to do or you need to be willing to hire someone else to do it.

It DOES require some knowledge. My friend, the late J.F. "Jim" Straw, used to emphasize that you can collect information or you can gain knowledge. The difference being, until you actually DO something and prove to yourself, it is ONLY information.

This is me hanging out with Jim and Ted Thomas (who taught me all about a investing in real estate via tax liens and tax defaulted properties). Let's focus on what Jim absolutely clarified in my mind, but if you'd like an introduction to Ted, just let me know. I expect Ted to make me "several million" dollars in 2021 :-)



It is only by doing it that information becomes your knowledge.

So, most of us typical humans, seeking the easiest path, really seek EXPERIENCE. Now, experience, you can gain by piggy-backing on what others have done and are willing to share with you.

Today, as I continue growing my business, but no longer really wanting to "work my fingers to the bones," I happily and willingly tap into the experience of others.

YOU can do the same, or you can put in the time and effort of months... years of trial and error, and if you are PERSISTENT, I DO "believe" that you will figure "it" out.

I personally now choose the softer, easier way. Twice a week, I tune into two masterminds sessions and learn from the EXPERIENCE of others.

In one of these masterminds, my friend since around the turn of the century, Marlon Sanders, allows a small group of us to join [a Zoom call](#) where he teaches us product development and how to successfully roll out a series of products... stacked one on top of the other :-)

Watch me over the next year or two, and you will see that I hung on to EVERY one of Marlon's words!

I have those calls hard SCHEDULED for every week, because I love how Marlon MASTERFULLY dissects the funnels of successfully marketed products. I don't have to reinvent the wheel. [I only need to listen, discuss, analyze and then test and implement](#) what Marlon uncovers for us.

In the other mastermind, my friend and one-time accountability partner, David Perdue, and his daughter Jen, lead a Zoom call for the [myNAMS Insiders](#). On those calls, we focus on one topic per month and dive really, really deep into it. December 2020 we deep-dived into all aspects of website traffic from generating it, to making sure that your emails get delivered, opened, read, and responded to.

I've been email marketing since 1996, yet I listened closely to the live Zoom calls, and sometimes went back through the recording... and the Zoom Chat Notes... where others on the calls often share unique tips and insights sometimes gained through DECADES of being in business.

[On David's calls, he graciously pulls back the curtain](#) and show you his actual stats from various campaigns of his 7-figure business. He freely shares what worked and what

didn't work so well... and we analyze WHY it did or didn't work.

I'm certain that you can appreciate the HUGE amount of time, and avoiding mistakes by learning from other, that DRIVE me to tune into both of those calls every week.

Those calls are so much a part of my life that my wife KNOWS exactly what I'll be doing each Wednesday at 1pm Eastern and each Thursday at 8pm Eastern :-)

I'm a "master multi-tasker" but as was also proven to me by Jim Straw, it's impossible to multi-task. The brain can't do that. Instead it RAPIDLY shifts its focus between tasks.

Jim's assertion was correct, but today I could prove to him that a second collections of neurons, far removed from the skull, CAN actually focus on something different, while the brain focuses on the task that you want to consciously focus on.

But, I'll blow your mind with that at another time. IF you are in [my Private FB Group](#), I'll probably share that with you soon ;-)

The point I was going to make is that when I tune in to Marlon's or David's mastermind calls, I shut out ALL distractions, except I sometimes turn off my camera and allow myself to enjoy a meal while learning :-)

THE purpose of this “long-ass” note is not to sell you on either of the above two group learning experiences. IF you enjoy being a lone-wolf, and learning on your own... I was once that way :-)

That was before life reminded me that “lone wolves often starve!”

I taught my rank and rent methodology during a 6-week course that I recorded, and offered as a product. A few month ago, I stopped selling the course as I focused more on...

I actively sought feedback from my students to include asking for changes they would like to see in a revised course.

NOW, I'm recording Version 2 of my training, incorporating SOME of their suggestions.

A few asked for a course that would be beyond the scope of anything I would attempt to put together and keep updated unless I had to charge at least \$5000 for it. I would need to keep spending so much to keep up with all of the little, short-lived tricks and loopholes, and all of the very latest search-engine changes ... which occur almost daily!

Version 2 will be shorter bite-sized lessons because I tried to pack so much in the previous 6 LONG recorded sessions that it's really difficult for a person to go back and review specific intricacies that I taught.

Version 2 will focus on teaching the lower-hanging fruit of ranking and then renting websites. I will NOT make you a search-engine guru. I did at one time focus on doing and teaching SEO. I worked on sites belonging to people that you'd probably recognize... Paul Hartunian, Bob Proctor... many other legends.

Paul Hartunian is "the man who sold The Brooklyn Bridge" which got him on the Johnny Carson Show, but also led to me becoming one of his students, and someone he actually recognize out on The Marketers Cruise.

Bob Proctor is a big Law Of Attraction expert, starred in The Secret along with several of my other friends, but when I was working on his website he was marketing Law of Attraction cassette tapes with an Australian named Michelle Blood. ... *I think that she's Aussie :-)*

In case you're wondering, I HAVE finally mastered The Law of Attraction, The Law of Expectations, understand karma, energy, quantum physics and a lot of that type of stuff.

Like many other things the secret is NOT a secret, it's just that most people don't seem to focus on things hidden in plain site.

Even though I said that there are no secrets, I did just share with you another non-secret to financial and business success... and to a successful life in general.

You DO need people that you can trust, depend upon, and work with in an environment that benefits everyone involved.
